# Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2025 of **Henllys Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

### Audit opinion: Unqualified

On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

#### Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council:

#### **Prior Year Restatement**

The 23/24 accounts were inappropriately prepared on an income & expenditure basis. The council have amended the year ended 31<sup>st</sup> March 2024 figures in the 24/25 Annual Return. The net balance of Line 9 and Line 10, as reported in the 23/24 Account Statement has been reported in the 24/25 Annual Return. This net balance is now shown on Line 10 of the 24/25 Annual Return, for the year ended 31<sup>st</sup> March 2024.

We recommend the Council reports any future amendments to the Accounting Statement in the Additional Disclosure Notes.

There are no further matters I wish to draw to the Council's attention.
